- 3. Legislative subcommittee
  - a. Paul met with the staff of Rep Rogers to put ourselves as a committee on their radar. Number of ideas came out of the meeting how can we be connected with the general court other than contact with representatives
    - i. There is a zero waste caucus focused on solid waste legislation Michele Cicolo (Lexington) is on it.
    - ii. New chairs on the joint committee on natural resources and ageyeball all the bills we're interested in.
    - iii. We could try to connect with groups or committees and the chairs. Constituent committees of the districts - they will respond to people within their districts
    - iv. Reach out to other community groups e.g. sustainable belmont

  - f. Jim wants to work with the subcommittee; he hopes that EPR legislation would include packaging; wants to work on the resolution.

- g. Larry talked about potentially gathering real world data on the effects of implementation of particular legislation (e.g. bottled water). This is to be seen as a results oriented or action oriented. Jim idea maybe we can do a survey
