Plan Overview

Final plan will identify at least 15 street improvement projects in Arlington that will expand safe and accessible options for all travel modes – walking, biking, transit and vehicles for people of all ages and abilities.

All projects included in Arlington's Complete Streets Prioritization
Plan update will be eligible for funding through
the Massachusetts Department of Transportation's Complete Streets
funding program.

Timeline

- Fall 2022: Project begins
- December 2022: Site visit with MAPC, Town of Arlington, and Kittelson
- January-February 2023: First survey is released for public feedback
- March 2023: Survey analysis, project list developed
- April-May 2023: Project sketches and cost estimates developed
- June 2023: Public meeting
- Summer 2023: Final plan is published and posted on Town website




Proactive planning provides a roadmap to achieve goals in a predictable manner.

Connect Arlington recommends building on the Town's completed sidewalk conditions analysis to develop a comprehensive sidewalk improvement program to implement and allocate funding to ensure the pedestrian network is safe and proactively maintained.

RECOMMENDED BICYCLE NETWORK




Developing a highly connected network of dedicated, preferably separated, bicycle lanes and facilities is a priority recommendation of Connect Arlington.

Building out a town-wide network would provide safer, more comfortable. and convenient facilities to encourage bicyclists of varying levels of experience and comfort to move around, reducing the need or preference to drive.

Massachusetts Environmental Justice Populations

Minority: the block group minority population is >= 40%, or the block group minority population is >= 25% and the median household income of the municipality the block group is in is < 150% of the Massachusetts median household income

Income: at least 25% of households have a median household income 65% or less than the state median household income


Language isolation: 25% or more of households do not include anyone older than 14 who speaks English very well

Mobility Options for All Ages, Capabilities, and Incomes

Continue to implement accessibility improvements throughout Arlington including sidewalk and access improvements (ramps, ADA parking, van parking) at schools, public buildings, recreation facilities and more.

Continue to develop and implement

Safe Routes to School

(SRTS) projects—programs and
infrastructure improvements—that aim
to provide safe transportation networks
for children to walk and bike from their
homes to their schools.

Reduced Climate Impacts from Travel in Arlington

Create and implement a plan to expand public electric vehicle charging at libraries, business districts, public parking and other facilities, both on- and off-street.

When designing and constructing any transportation facilities, include **low impact**, "green" design interventions and construction techniques to reduce climate impacts including those that reduce impermeable surfaces to the greatest extent, reduce heat island impacts, increase water retention on-site, etc.



Survey Overview

1,200+ responses

The first of two surveys was released in February 2023.

First survey goals:

- Provide overall feedback about experience using various modes of travel in town
- Identify specific streets and intersections to consider as part of the project list

Second survey:

- Available summer 2023
- Present a draft list of at least 15 projects for feedback

Final plan will identify at least 15 street improvement projects in Arlington that will expand safe and accessible options for all travel modes – walking, biking, transit and vehicles – for people of all ages and abilities

Final Complete Streets Prioritization Plan will be completed in the summer of 2023



Who Responded?




95% of respondents were Arlington Residents.

Majority of respondents were ages 35 and up.

More than half of respondents have vulnerable road users living at home (Children 18 and under, Seniors over 65).




How do you typically travel within Arlington? (Check all that apply)





If conditions within Arlington were safer, more efficient, or easier, how would you choose to travel on a regular basis? (Check all that apply)







Projects Overview

The draft project list proposes 18 projects to improve conditions for people walking, biking, rolling, driving, and riding the bus.

Process to develop list:

- Reviewed existing conditions and previous plans
- Conducted site visit with project team
- Released a public survey
- Analyzed survey results
- Assessed near to medium-term feasibility
- Integrated DPW, DPCD, APD priority projects

Major changes:


- Improvements for biking, walking, and bus connections
- Curb bump outs to slow traffic and enhance safety for all users
- More crosswalks for better connections across busy streets
- Safety changes at high-crash sites












Example Changes – Broadway at Bates Rd, River St, Warren St

- Close off Warren St between River St. and Broadway
- Expand public open space
- Simplify intersection geometry
- Add curb extensions with new curb ramps and crosswalks
- Add new crosswalks across Broadway at bus stops
- Create clear corners for better visibility



Example Changes – Mass. Ave at Dundee Rd and Paul Revere Rd


- Tighten intersections with curb extensions and rain gardens
- Add parking-protected and buffered bike lanes
- Right-size bus stops
- Add Rectangular Rapid Flashing Beacons (RRFBs) across Mass Ave
- Add crossing to bus stop at Drake Rd




Example Changes – Park Ave from Wollaston Ave to Downing Square

- Tie-in to existing bike lanes from Appleton St to Wollaston Ave
- Add parkingprotected bike lanes from Paul Revere Rd to Mass. Ave
- Add bike Lanes from Mass. Ave to Downing Square
- Stripe bike lanes through intersections

All project sketches are preliminary concepts



Example Changes – Park Ave from Wollaston Ave to Downing Square



Example Changes – Park Ave at Paul Revere Rd and Wollaston

- Improve bus stop accessibility
- Add curb extension with landscaping opportunity
- Add hardened centerline for traffic calming
- Simplify intersection by restricting Paul Revere Rd through movement
- Add bike lanes and protected bike lanes
