Minutes

Meeting called to order at: 6:33pm

- 1. Remote Participation Statement and Guidelines
  - a. Read

- 2. Land Acknowledgement
  - a. Read
- 3. Commission Membership: Laura Gitelson resigned from Rainbow Commission as she is now new member of School Commission
- 4. Review and approval of March 2023 Minutes
  - a. SRV motioned to approve; AR seconded the motion; all approved.
- 5. Overview of Rainbow Commission response to curriculum challenge
  - a. 300 Arlington residents showed support; 50 wrote testimony. Teachers, Parents, Town employees, residents all showed support. 150 people at First Parish to celebrate inclusive community in Arlington.
  - b. DEI department has built strong networks of community groups and Commission members worked with town systems and other community groups in response to curriculum challenge.
  - c. KG asks how Commission learned about the situation and wants to know if a protocol can be established with town when LGBTQIA+ rights are under attack that the DEI Commissions are immediately notified. SRV and MG say that Rainbow Commission learned of the situation via public comment at School Committee meeting and via work with APS Rainbow Task Force.
  - d. No one on Rainbow Commission has been told why the complaint was withdrawn.
  - e. What can we do if/when this happens again? Commission will create a response template based on what it learned from this work when/if something similar happens again.
  - f. Stacey parent: Asked about how individuals who have never testified or advocated can prepare to participate/respond in the future. Len Diggins advised to share personal stories with elected officials.
- 6. APD response to anti-LGBTQIA+ graffiti near Blue Bikes on Linwood Avenue
  - a. Incidents began in March repeatedly. APD had plainclothes officers assigned to scene and eventually made an arrest. Mental health issues are a significant component of why incidents occurred and APD's mental health clinician is working with the resident, who is now on probation. APD remains vigilant.
  - b. Question about how much information is required to make complaint. Online form asks a lot of the person making the complaint. Other options include anonymous call to police with complaint; or use the anonymous tip line https://www.arlingtonma.gov/departments/police/tip411-submit-an-anonymous-tip. Suggestion that APD and Rainbow Commission (and other community groups) could promote the anonymous ways to file complaints.

Things are still finalizing, but it looks like we will have a last-minute addition of a second drag performer, who is a college freshman who attended previous Pride Proms as a teen!
