Sealed Bids are invited and will be received by the Town Manager, Town of Arlington, Massachusetts, until **10:00 a.m., Thursday, August 31, 2023**, at the Town Manager's Office/Purchasing Department, Town Hall Annex, 730 Massachusetts Ave, Arlington, Massachusetts, 02476, at which time and place they will be publicly opened and read for:

BID #23-55, ELEVATOR MAINTENANCE SERVICE CONTRACT VARIOUS BUILDINGS

No bid shall be accepted, nor shall any Bid be corrected, modified, or withdrawn, after the bid deadline.

Bid documents will be available for download after 11:00 a.m. on **Thursday, August 17, 2023**, from the Town's website: arlingtonma.gov/purchasing.

Bidders are advised that to be eligible to bid on this project they must be certified by the Massachusetts Division of Capital Asset Management and Maintenance (DCAMM) in the category of **Elevators** and that their bids must be accompanied by a Prime/General Contractor Certificate of Eligibility issued by DCAMM and a Prime/General Contractor Update Statement completed and signed by the Bidder.

Bid Deposits: Every Bid shall be accompanied by a bid deposit in an amount not less than 5% of the value of the Bid, including any and all alternates. Bid deposits shall be in the form of a bid bond, or cash, or a certified check on, or a treasurer's or cashier's check issued by, a responsible bank or trust company and payable to the Town of Arlington. Bidders are reminded that the bid deposit covers the Town for damages when a Bidder withdraws its bid after the bid deadline. The Town will retain all bid deposits for withdrawn bids to the extent permitted by law.

Minimum Wage Rates, as determined by the Director of the Massachusetts Department of Labor Standards under the provisions of M.G.L. c.149 §§26 to 27H, shall prevail in the execution of the work of this project. The schedule of wage rates applicable to this contract is included in the bid and contract documents.

Bids must be submitted on the form provided and in a sealed envelope plainly marked with the name, address, and phone number of the Bidder and with the words "ELEVATOR MAINTENANCE SERVICE CONTRACT, VARIOUS BUILDINGS, BID #23-55."

The Town will reject any and all bids when required to do so by Massachusetts General Laws. The Town reserves the right to waive any informalities in, or to reject any and all bids, if it deems it to be in the public interest so to do. The Town also reserves the right to reject any bid if it determines that such bid does not represent the bid of a person or firm competent to perform the work as specified, or if fewer than three bids are received, or if bid prices are not acceptable without further competition.

Rule for Award: It is the intention of the Town to award one (1) contract to the responsible and eligible bidder submitting the lowest price for Year 1 based on the unit prices proposed by the Bidder and the estimated quantities provided by the Town. The Contract is for the period beginning on the date the contract is executed and ending June 30, 2024. The Town, at its sole discretion, may exercise two one-year options to renew, first for the period July 1, 2024, through June 30, 2025, and second for the period July 1, 2025, through June 30, 2026.

The successful Bidder will be required to furnish, within 10 days of notification of contract award, both a **Performance Bond** and a **Labor and Materials or Payment Bond**, each in the amount of 100% of the contract.

The successful Bidder will be required to provide a Certificate of Insurance demonstrating current coverage of the kind and in the amounts as follows:

The Town of Arlington shall be named as additional insured on the contractor's liability policies.

Massachusetts General Laws are incorporated herein by reference. Any inconsistency between the Invitation for Bids, Instructions to Bidders, Bid Forms, Conditions of the Contract, and any other Contract Documents and these statutes, or any other applicable statutes, bylaws, or regulations existing on the date on which the bids are to be received, shall not be grounds for invalidating the bidding procedures, but, where required by law, such statute, bylaw, or regulation shall be deemed to govern.

INSTRUCTIONS TO BIDDERS

1) BIDDER'S REPRESENTATION

- a) Each General Bidder (hereinafter referred to collectively as the "Bidder") by making a bid (hereinafter collectively referred to as "bid") represents that:
 - The Bidder has read and understands the Contract Documents and the bid is made in accordance therewith.
 - ii) The Bidder has been given the opportunity to visit the work site and is familiar with the local conditions under which the work is to be performed.
- b) Failure to so examine the Contract Documents or visit the work site will not relieve any Bidder from any obligation under the bid as submitted.

2) REQUEST for INTERPRETATION

- a) Bidders shall promptly notify the Town of any ambiguity, inconsistency, or error which they may discover upon examination of the Contract Documents, the site, and local conditions.
- b) Bidders requiring clarification or interpretation of the Contract Documents shall make a written request to the Purchasing Agent at mdenatale@town.arlington.ma.us. The Town will only answer such requests if received at least six (6) days before the scheduled bid opening.
- c) Interpretation, correction, or change in the Contract Documents will be made by addendum which will become part of the Contract Documents. Oral interpretations generally will not be made and, if made, shall be strictly informal and not legally valid or binding.
- d) Addenda will be available for download from the Town's website www.arlingtonma.gov/purchasing. Bidders are solely responsible for obtaining addenda before the bid opening. Failure to acknowledge each and every addendum in the spaces provided on the Bid Form may result in rejection of that Bidder's bid.
- e) Bidders or proposers contacting any Town employee regarding this IFB other than the Purchasing Agent, once the IFB has been issued, may be disqualified from the procurement process.

3) PREPARATION and SUBMISSION of BIDS

- a) Bids shall be submitted on the Bid Form provided in the bid and contract documents.
- b) All entries on the Bid Form shall be made by typewriter or in ink.
- c) Where so indicated on the Bid Form, sums shall be expressed in both words and figures. Where there is a discrepancy between the bid sum expressed in words and the bid sum expressed in figures, the words shall govern.
- d) No interlineations, additions, alterations, or erasures shall be made on the forms.
- e) Bid Deposits shall be submitted in the amount specified in the Invitation for Bids and shall be in the form of (1) cash, (2) a certified check on, or a treasurer's or cashier's check issued by, a responsible bank or trust company and payable to the Town of Arlington, or (c) a bid bond in a form satisfactory to the Awarding Authority, issued by a surety company qualified to do business in the Commonwealth of Massachusetts, and conditioned upon the faithful performance by the principal of the agreements contained in the bid. Bidders are reminded that the bid deposit covers the Town for damages when a bidder withdraws its bid after the bid submission date. Be advised that to the extent permitted by law, the Town will retain all bid deposits for withdrawn bids. Bid deposits of the three (3) lowest responsible and eligible Bidders shall be retained until the execution and delivery of the Town-Contractor agreement.

- f) Each Bid, including the bid deposit, shall be properly executed and enclosed in a sealed envelope and plainly marked on the outside with the bidder's name, business address, and phone number and the words "#23-55 Elevator Maintenance Service Contract Various Buildings"
- g) Date and time for receipt of bids is set forth in the Invitation for Bids
- h) Timely delivery of bids shall be the full responsibility of the Bidder. In the event Arlington Town Hall is closed on the date or at the time that bids are due, the date and time for receipt of bids shall be on the next business day following that the Town Hall and the Purchasing Department are open.
- i) Bids shall be submitted with one **original** and one **copy**.
- j) Massachusetts law requires that all employees who work on Massachusetts public works construction sites have no less than 10 hours of OSHA-approved safety and health training. See M.G.L. c.30, §39M(c), M.G.L. c.30, §39S(a)(1), M.G.L. c.149, §44E(2), and M.G.L. c.149, §44F(2).
 - i) This requirement will apply to any bid submitted.
 - ii) This law directs the Massachusetts Attorney General to restrain the award of construction contracts to any contractor who is in violation of this requirement and to restrain the performance of these contracts by non-complying contractors.
 - iii) All Bidders must certify on the Bid Form compliance with the applicable requirement. Non-compliance with this law will disqualify the Bidder.

4) MODIFICATION OR WITHDRAWAL OF BIDS

- a) Any bid may be withdrawn prior to the time designated for receipt of bids upon written or electronic request. Electronic withdrawal of bids must be confirmed over the Bidder's signature by written notice postmarked on or before the date and time set for receipt of bids.
- b) Withdrawn bids may be resubmitted until the time designated for the receipt of bids.
- c) No bid may be withdrawn within forty-five (45) days, Saturdays, Sundays, and legal holidays excluded, after the opening of the bids.

5) **CONTRACT AWARD**

- a) The Town will award one (1) contract to the responsible and eligible Bidder submitting the lowest Total Base Bid Price for labor and materials as set forth in the Bid Form. A contract will be awarded within sixty (60) days, Saturdays, Sundays, and legal holidays excluded, after the opening of bids.
- b) The Town reserves the right to waive minor informalities in or to reject any or all bids if it be in the public interest so to do.
- c) As used herein, the term "lowest responsible and eligible Bidder" shall mean the Bidder (1) whose bid is the lowest of those bidders possessing the skill, ability, and integrity necessary for the faithful performance of the work; (2) who has met all the requirements of the Invitation for Bids; (3) who shall certify that he is able to furnish labor that can work in harmony with all other elements of labor employed or to be employed in the work; (4) who, where the provisions of section eight B of chapter twenty-nine apply, shall have been determined to be qualified thereunder.
- d) Subsequent to the award and within five (5) days, Saturday, Sundays and legal holidays excluded, after the prescribed forms are presented for signature, the successful Bidder shall execute and deliver to the Town a contract in the form included in the Contract Documents in such number of counterparts as the Town may require.
- e) Should the Town receive low bids in identical amount from two or more responsive and responsible Bidders, the Town shall select the successful Bidder by a blind process chosen by the Town, such as flipping a coin or drawing names from a hat. The low Bidders under consideration will be invited to attend and observe the selection process.

6) TAXES

- a) The Bidder shall not include in its bid any tax imposed upon the sale or rental of tangible personal property in this Commonwealth, such as any and all building materials, supplies, services or equipment required to complete the work.
- b) The Town is exempt from payment of the Massachusetts Sales Tax, and the Bidder shall not include any sales tax on its bid.

SPECIFICATIONS

I. DESCRIPTION OF WORK

The work of this contract shall be the furnishing of all labor, materials, equipment, and supervision necessary for the regular and systematic inspection, maintenance, and repair of elevators and wheelchair lifts and related equipment in buildings operated by the Town of Arlington. The work shall include quarterly inspections, services related to annual testing and permitting as required by state regulation, and emergency and non-emergency repairs, as needed.

A. Quarterly Inspections

The Contractor shall provide quarterly inspections of all Town elevators and wheelchair lifts to ensure that all mechanical, electrical, and safety systems are operating in accordance with manufacturer's specifications. Such inspections shall also include lubrications and adjustments as specified by the manufacturer, as well as the identification of repairs requiring additional work.

The Contractor shall make four (4) scheduled calls per elevator per year, at which time the Contractor shall inspect, clean, oil/grease, and adjust each unit. Inspections must be performed between the hours of 7:00 a.m. and 4:00 p.m. and during the following periods only:

First Quarter Inspection FIRST 15 DAYS IN JULY
Second Quarter Inspection FIRST 15 DAYS IN OCTOBER
Third Quarter Inspection FIRST 15 DAYS IN JANUARY
Fourth Quarter Inspection FIRST 15 DAYS IN APRIL

The Contractor shall be paid a flat fee for the quarterly inspection of each location in accordance with the unit price submitted with his bid. The unit price for each inspection shall include, but not be limited to, overall inspection of equipment in accordance with the checklist provided below, minor parts such as nuts, bolts, screws, washers, pins, and clamps, and any miscellaneous lubricants such as grease and oil. Hydraulic oil shall be billed separately.

Quarterly Inspection Checklist

The checklist shall include but is not limited to:

- 1. Check all operations of elevator.
- Clean out the pit, remove all debris from pit.
- 3. Clean and oil machine motor, interlocks and controller.
- 4. Adjust and lubricate all working parts, including guides.
- 5. Check to make sure elevator stops at each floor safely and correctly.
- 6. Check all controls (call buttons/switches) at each floor.
- Test all safety devices and governors.
- 8. Check tension of all hoisting cables and equalize.
- Renew guide shoe gibs as necessary.
- 10. Any other regularly accepted industry practices.

Any repairs that must be performed at the time of the inspection shall be performed on a time and materials basis following the approval of the Facilities Director or their designee. For any additional

repairs, the Contractor shall prepare a written proposal, in the manner set forth herein, and submit said proposal within five (5) business days of the inspection to the Facilities Director or their designee for review.

B. Annual State Inspections

The Contractor shall coordinate and provide services related to annual testing and permitting of all units as required by law. The Contractor shall contact the Office of Public Safety and Inspections to schedule the inspections and shall complete any application(s), pre-inspection checklist(s), or other related forms. The Contractor shall receive a copy of the State Inspector's report and attach it with the service slip to the invoice for work performed. A duplicate copy of the Inspector's report must be submitted to the Facilities Director or their designee. In the event an elevator or lift does not pass inspection, the Contractor shall provide a written proposal within five (5) business days of the inspection for any work that is needed so that the unit can pass inspection and receive a certificate.

The Contractor shall be paid a flat fee per inspection, in accordance with the unit price submitted in its bid. That unit price shall include both the Contractor's labor and the state inspection fee. The Contractor cannot charge the Town for any weights that may be needed in order to test the elevator for the Inspector, nor shall it charge the Town for time traveling to and from the site, or for any sundries or vehicle charges.

C. Repairs

The Contractor shall perform all repairs identified by the Contractor during quarterly inspections and requested by the Town or identified by the Contractor or the Town at other times, including service outages. The Contractor shall **ONLY** repair what he is instructed to repair. If there are any questions regarding the repair work that is to be performed, the Contractor must contact the Facilities Director or their designee before proceeding. The Contractor shall diagnose any problem and make the necessary repairs as quickly and efficiently as possible. All permanent repairs must be made at a minimum within five (5) days after the problem has been diagnosed and approval to proceed has been granted. If temporary repairs are needed due to an emergency, the Contractor shall do so at the direction of the Facilities Director or their designee. All repairs must be of professional quality and left in a safe and workable condition.

The Contractor will be paid on a time and materials basis in accordance with the hourly rate and mark-up for materials and supplies submitted in the Contractor's bid.

D. Tools and Equipment

The Contractor shall provide all the tools and equipment necessary to perform the work under this contract. The tradesperson must bring to the site the proper and basic tools, as applicable. The Town shall not be charged for the use of equipment the Contractor may need to complete a job. The Town shall not be responsible for any of the tradesperson's equipment that is lost, stolen or damaged.

The Contractor may use the site's existing services if available, including water and electricity, to complete a job; however, if the Town determines that the Contractor is abusing access to these services, permission shall be revoked, and the Town may charge the Contractor for its use of said services.

II. BUILDING LOCATIONS and BILLING ADDRESSES

The physical location and billing address for each building is listed below. Bidders should visit each building to verify and become familiar with the equipment prior to bidding. Note that for most buildings, the billing address is not the same as the physical location. Invoices must be mailed to the appropriate department and billing address.

III. PROPOSALS

From time to time, the Town will require the Contractor to provide a proposal to perform work. Before submitting a proposal, the Contractor shall visit the site. All proposals shall contain:

- Name and location of building
- Total cost (labor and materials)
- Breakdown of costs, including, for labor, number of workers and number of hours, and, for materials, types and quantities.
- Special equipment needed.
- Other special conditions.
- Exact and specific description of the work to be done.

- Number of days to complete the job.
- Number of days needed to start the job after receiving authorization.

If the Town accepts the proposal, the Contractor shall perform the work on a time and materials basis, not to exceed the quoted price. Service slips must be made available upon request of the Facilities Director or their designee.

IV. FIXED HOURLY RATE

Bidders must quote as part of their bid a regular hourly labor rate for any repair work performed between the hours of 7:00 a.m. and 5:00 p.m., Monday through Friday. Time begins when the tradesperson arrives at the site and ends when he or she leaves the site. The Contractor shall not charge the Town for any time, mileage, or other costs associated with a tradesperson traveling to and from the site. The Contractor shall take this into account when calculating the proposed hourly rate. The Contractor may charge the Town, at the hourly rate proposed in his bid, for time associated with picking up parts or supplies required for a repair.

V. SERVICE SLIPS

For each time a tradesperson enters a building to do work, the Contractor must provide the Town with a service slip/work order describing the work. The slip must include:

- the company name, address, telephone number and tradesperson's complete name,
- the specific location in the school or building where the work was performed, including panel numbers or room number, as appropriate,
- an exact and specific description of the work performed, including details about the unit and its related characteristics, to the extent possible,
- a description of any and all materials used, including amounts, manufacturer, type, model number and any other pertinent information,
- a description of the cause of the failure, noting any outstanding items or problems that still exist,
- the start time and the completion time of the work that was performed and the date on which it was completed,
- the exact number of hours/minutes the tradesperson was on site while working on the problem,
- the date on which the tradesperson plans to return to complete the work by, and
- a description of any additional work the Contractor believes may be needed in the near future to ensure proper operation or maintenance.

This slip must be signed by and left with the Facilities Director or his designee. No other person's signature will be accepted. A copy of this slip shall also accompany the invoice.

VI. INVOICES

The Contractor shall prepare all invoices in the following manner:

- All invoices must be original and dated properly and accurately.
- A copy of the service slip must accompany the invoice.
- The Contractor shall not submit an invoice until all work has been completed.
- Invoices must be mailed to the correct department and billing address.

The Contractor shall provide on the invoice all pertinent information, including.

- the number of hours worked, multiplied by the fixed hourly rate,
- any and all materials used for the job with their individual prices, and
- a brief description of the work performed.

The Contractor shall not charge the Town for any time traveling to and from the site, or for any sundries or vehicle charges. If the Contractor uses materials or services from an outside vendor, the Contractor's invoice must state the cost to the Contractor for those items plus no more than the percent mark-up submitted as part of the Contractor's bid. Invoices for work not completed to the satisfaction of the Town will not be paid until the work is properly completed. The Town will not pay any invoice to which the Contractor fails to attach proper documentation.

VII. OVERCHARGING (MATERIALS)

If the Town has reason to question the validity of an invoice, the Facilities Department shall notify the Contractor in writing. The Contractor shall have five (5) business days to answer any and all questions and to provide the Facilities Department with any requested proof, including a copy of the invoice that the Contractor received from the outside vendor for supplies or services and proof that said invoice was paid by the Contractor. The invoice must be a legitimate copy, dated and with the supplier's company name, address and telephone number and the name of a contact person. The Town may request from the Contractor a copy of any list prices from the outside vendor with whom the Contractor conducts his business for materials.

VIII. SERVICE CALLS

A. Contact Persons

Under no circumstances shall any service calls be received by the Contractor by any source other than those persons listed below. The Contractor shall make no plans to repair any item in any Town building without the explicit permission of the Facilities Director or their designee.

For service calls Monday through Friday, between 7:00 a.m. and 5:00 p.m., exclusive of holidays, the primary and secondary contact persons will be:

B. One/Eight Hour Services

The Contractor shall return all calls for service within one (1) hour. The Contractor shall commence all emergency service repair work within eight (8) hours of receiving a request for service by the Facilities Department when a call is made between 7:00 a.m. and 5:00 p.m., Monday through Friday.

IX. COMPLETED WORK

All completed work must be left in full operating order and in a safe condition where no harm can come to any person because of a lack of ordinary care. It will be the responsibility of the tradesperson to test the operation of the equipment/repair or prove the work was successfully completed in the presence of the Facilities Director or their designee. This must be noted on the order/service slip. The Facilities Department Representative will sign the slip.

X. CORRECTIONS TO WORK

If the Town, at its sole discretion, determines that any part of the work performed by the Contractor is not adequate, the Town shall, by written notice, instruct the Contractor to make the required corrections. If the Contractor shall neglect to make such corrections to the satisfaction of the Town within five (5) business days from the date of such notice, the Town may at its sole discretion cancel the contract. The Town may also employ other persons to make the corrections. The Contractor agrees to pay to the Town upon demand all amounts which it expends for such corrective services. If the Contractor persistently fails to carry out the work in accordance with the contract documents, the Town will cause this contract to be cancelled.

XI. SUBCONTRACTED WORK(ERS)/NON-SPECIFIED WORKER(S)

No work may be subcontracted for any reason without explicit permission of the Town. If any tradesperson from any other company or a non-specified worker from the contracted company is found on Town property without permission, that person will be asked to leave the premises. If any tradesperson from another company is found on Town property without permission and that person was sent by the company with which the Town has a contract, the Town will have absolute grounds for cancellation of the contract.

XII. WARRANTIES/GUARANTEES

All labor shall be guaranteed for a period of not less than one (1) year. There shall be a manufacturer's warranty for all materials used. If a part fails within the manufacturer's warranty period, the Contractor shall replace said part free of charge.

XIII. GENERAL REQUIREMENTS

A representative of the Contractor shall meet with the Facilities Director or their designee for an

introductory meeting, upon execution of the contract, in order to discuss procedures for service, the terms of the contract, and any questions either party may have.

All work shall comply in every respect with local, state, and federal laws and regulations, including, but not limited to, the requirements of the Massachusetts Office of Public Safety and Inspections. Unless otherwise specified in the contract documents, the Contractor shall secure and pay for all approvals, permits, certificates, licenses, and fees as may be required by law.

In the event of accidental site damage, it will be the responsibility of the Contractor to return the site to its original condition at no cost to the Town.

All equipment and materials specified to be removed from the site shall become the property of the Contractor, unless otherwise specified. It will be the responsibility of the Contractor to leave the area in a clean, "broom swept" condition, and to remove all debris generated during the work.

The Town reserves the right to terminate the contract immediately if it appears that any job is not being performed as expeditiously as possible.

By executing this contract, the Contractor represents that he has familiarized himself with the local conditions under which the work is to be performed.

No job will have more than one (1) tradesperson working at a time unless explicit permission is granted by the Facilities Department. If the Contractor sends more than one tradesperson to the site without permission, it will be at the Contractor's own expense.

No single job that would cost more than \$1,000.00 shall be commenced by the Contractor without the prior consent of the Facilities Director or their designee.

No single job shall exceed \$5,000.00 under the terms of this contract

GENERAL CONTRACT

This Contract is for Elevator Maintenance Service Contract/Various Buildings as per Bid #23-55 for the Town of Arlington, Massachusetts.

This Agreement made this _____ day of _____ 2023 by and between

(Contractor)
party of the first part, (hereinafter called the Contractor) and the Town of Arlington, a municipal corporation located in Middlesex County, party of the second part, (hereinafter called the Owner), by its Town Manager.

WITNESSETH:

That the Contractor and the Owner, for valuable consideration agree as follows:

Article 1. The Contractor shall provide all the materials and perform all the work necessary for and incidental to the work as described and shown in the specifications hereto annexed and the plans as may be identified by the signatures of the parties thereto, in all respects in accordance with said plans and the provisions of said specifications, and all such plans and specifications, together with the general instructions notice to Contractor and proposal are hereby made a part of this contract.

Article 2. Guarantee: The Contractor agrees to replace any imperfect work which may develop within a period of one (1) year from the completion of the work, with new and correct work as may be required by the Town Manager.

Article 3. Should the Contractor fail to prosecute promptly the work or to perform any agreement herein contained, the Owner shall be at liberty, after three (3) days written notice to the Contractor, to provide labor and materials and deduct the cost thereof from any money then due or thereafter to become due to the Contractor under this agreement, and the Owner shall further have the right to terminate the employment of the Contractor for said work and to complete the work included under this agreement and provide all the necessary labor and materials therefor. And in case of such discontinuance of the Contractor's employment he shall not be entitled to

receive any further payment under this agreement until such work shall have been wholly completed. If the unpaid balance of the contract price herein shall exceed the expense of completing the work, such excess shall be paid to the Contractor. If such expense shall exceed the unpaid balance, the Contractor shall pay the difference to the Owner.

Article 4. It is hereby mutually agreed between the parties hereto that the sum to be paid by the Town of Arlington to the Contractor for said work and materials shall be \$______ the said sum to be subject to additions and deductions and to be paid all according to the provisions of the specifications.

Article 5. The Contractor shall not assign his interest in this agreement without the prior written consent of the Owner nor shall the Contractor assign any moneys due or to become due hereunder without such prior written consent.

Article 6. The Contractor shall take all responsibility of the work and take all precautions for preventing injuries to persons and property in or about the work, and indemnify and save harmless the Owner and Town Manager and his representatives from all claims either for payment by the Contractor, subcontractor or others for labor and materials furnished for the work, or relating to injuries to any person, corporation or property received or sustained by or from the Contractor or any subcontractor, or his employees doing the work or in consequence of improper materials, implements or labor used therein, or relating to any act, omission or neglect of the Contractor and his employees therein or any subcontractor.

Article 7. The Contractor shall procure and deliver to the Owner the prior written approval of the surety on the bond accompanying the contract, of any and all payments to be made by Owner, and the Contractor shall have no right to any such payment without such approval and delivery thereof to the Owner provided, however, that such approval shall not be required if the Contractor shall first procure and deliver to the Owner a written waiver by such surety of any right to approve any and all payments and a written agreement by such surety to make no claim that any payment made and to be made by the Owner was improperly made.

Article 13. Contract Documents: The foregoing Articles, copies of the contractor's proposal, all related specifications and drawings, the contractor's bond, all correspondence constituting mutual agreements, together with this Agreement, for and are as fully a part of the contract as if hereto attached or herein repeated.

Article 14. It is agreed that the powers and rights herein given to the Owner may be exercised by the Town Manager. That the Town Manager shall not be under any personal obligation or liability by reason of this agreement, the execution thereof, the work or any other thing herein mentioned.

Article 15. The contractor agrees to begin work on _____ and complete said work on June 30, 2024. The Contract may be renewed for a second and third year at the sole discretion of the Town.

The contractor for itself and for its heirs, administrators, successors and assigns, and the Owner for itself, its successors and assigns, hereby agree to the full performance of the terms of this agreement.

SPECIAL CONDITIONS COMMONWEALTH OF MASSACHUSETTS & TOWN OF ARLINGTON

Article 1. Method of Paying Subcontractors (M.G.L. c. 30 §39F)

- (1) Every contract awarded pursuant to sections forty-four A to L, inclusive, of chapter one hundred and forty-nine shall contain the following subparagraphs (a) through (i) and every contract awarded pursuant to section thirty-nine M of chapter thirty shall contain the following subparagraphs (a) through (h) and in each case those subparagraphs shall be binding between the general contractor and each subcontractor.
- (a) Forthwith after the general contractor receives payment on account of a periodic estimate, the general contractor shall pay to each subcontractor the amount paid for the labor performed and the materials furnished by that subcontractor, less any amount specified in any court proceedings barring such payment and also less any amount claimed due from the subcontractor by the general contractor.
- (b) Not later than the sixty-fifth day after each subcontractor substantially completes his work in accordance with the plans and specifications, the entire balance due under the subcontract less amounts retained by the awarding authority as the estimated cost of completing the incomplete and unsatisfactory items of work, shall be due the subcontractor; and the awarding authority shall pay that amount to the general contractor. The general contractor shall forthwith pay to the subcontractor the full amount received from the awarding authority less any amount specified in any court proceedings barring such payment and also less any amount claimed due from the subcontractor by the general contractor.
- (c) Each payment made by the awarding authority to the general contractor pursuant to subparagraphs (a) and (b) of this paragraph for the labor performed and the materials furnished by a subcontractor shall be made to the general contractor for the account of that subcontractor; and the awarding authority shall take reasonable steps to compel the general contractor to make each such payment to each such subcontractor. If the awarding authority has received a demand for direct payment from a subcontractor for any amount which has already been included in a payment to the general contractor or which is to be included in a payment to the general contractor for payment to the subcontractor as provided in subparagraphs (a) and (b), the awarding authority shall act upon the demand as provided in this section.
- (d) If, within seventy days after the subcontractor has substantially completed the subcontract work, the subcontractor has not received from the general contractor the balance due under the subcontract including any amount due for extra labor and materials furnished to the general contractor, less any amount retained by the awarding authority as the estimated cost of completing the incomplete and unsatisfactory items of work, the subcontractor may demand direct payment of that balance from the awarding authority. The demand shall be by a sworn statement delivered to or sent by certified mail to the awarding authority, and a copy shall be delivered to or sent by certified mail to the general contractor at the same time. The demand shall contain a detailed breakdown of the balance due under the subcontract and also a statement of the status of completion of the subcontract work. Any demand made after substantial completion of the subcontract work shall be valid even if delivered or mailed prior to the seventieth day after the subcontractor has substantially completed the subcontract work. Within ten days after the subcontractor has delivered or so mailed the demand to the awarding authority and delivered or so mailed a copy to the general contractor, the general contractor may reply to the demand. The reply shall be by a sworn statement delivered to or sent by certified mail to the awarding authority and a copy shall be delivered to or sent by certified mail to the subcontractor at the same time. The reply shall contain a detailed breakdown of the balance due under the subcontract including any amount due for extra labor and materials furnished to the general contractor and of the amount due for each claim made by the general contractor against the subcontractor.

- (e) Within fifteen days after receipt of the demand by the awarding authority, but in no event prior to the seventieth day after substantial completion of the subcontract work, the awarding authority shall make direct payment to the subcontractor of the balance due under the subcontract including any amount due for extra labor and materials furnished to the general contractor, less any amount (i) retained by the awarding authority as the estimated cost of completing the incomplete or unsatisfactory items of work, (ii) specified in any court proceedings barring such payment, or (iii) disputed by the general contractor in the sworn reply; provided, that the awarding authority shall not deduct from a direct payment any amount as provided in part (iii) if the reply is not sworn to, or for which the sworn reply does not contain the detailed breakdown required by subparagraph (d). The awarding authority shall make further direct payments to the subcontractor forthwith after the removal of the basis for deductions from direct payments made as provided in parts (i) and (ii) of this subparagraph.
- (f) The awarding authority shall forthwith deposit the amount deducted from a direct payment as provided in part (iii) of subparagraph (e) in an interest-bearing joint account in the names of the general contractor and the subcontractor in a bank in Massachusetts selected by the awarding authority or agreed upon by the general contractor and the subcontractor and shall notify the general contractor and the subcontractor of the date of the deposit and the bank receiving the deposit. The bank shall pay the amount in the account, including accrued interest, as provided in an agreement between the general contractor and the subcontractor or as determined by decree of a court of competent jurisdiction.
- (g) All direct payments and all deductions from demands for direct payments deposited in an interest-bearing account or accounts in a bank pursuant to subparagraph (f) shall be made out of amounts payable to the general contractor at the time of receipt of a demand for direct payment from a subcontractor and out of amounts which later become payable to the general contractor and in the order of receipt of such demands from subcontractors. All direct payments shall discharge the obligation of the awarding authority to the general contractor to the extent of such payment.
- (h) The awarding authority shall deduct from payments to a general contractor amounts which, together with the deposits in interest-bearing accounts pursuant to subparagraph (f), are sufficient to satisfy all unpaid balances of demands for direct payment received from subcontractors. All such amounts shall be earmarked for such direct payments, and the subcontractors shall have a right in such deductions prior to any claims against such amounts by creditors of the general contractor.
- (i) If the subcontractor does not receive payment as provided in subparagraph (a) or if the general contractor does not submit a periodic estimate for the value of the labor or materials performed or furnished by the subcontractor and the subcontractor does not receive payment for same when due less the deductions provided for in subparagraph (a), the subcontractor may demand direct payment by following the procedure in subparagraph (d) and the general contractor may file a sworn reply as provided in that same subparagraph. A demand made after the first day of the month following that for which the subcontractor performed or furnished the labor and materials for which the subcontractor seeks payment shall be valid even if delivered or mailed prior to the time payment was due on a periodic estimate from the general contractor. Thereafter the awarding authority shall proceed as provided in subparagraph (e), (f), (g) and (h).

Article 2. Method of Paying General Contractors (M.G.L. c. 30 §39K)

Every contract for the construction, reconstruction, alteration, remodeling, repair or demolition of any public building by the commonwealth, or by any county, city, town, district, board, commission or other public body, when the amount is more than five thousand dollars in the case of the commonwealth and more than two thousand dollars in the case of any county, city, town, district, board, commission or other public body, shall contain the following paragraph:— Within fifteen days (30 days in the case of the commonwealth, including local housing authorities) after receipt from the contractor, at the place designated by the awarding authority if such a place is so designated, of a periodic estimate requesting payment of the amount due for the preceding month, the awarding authority will make a periodic payment to the contractor for the work performed during the

preceding month and for the materials not incorporated in the work but delivered and suitably stored at the site (or at some location agreed upon in writing) to which the contractor has title or to which a subcontractor has title and has authorized the contractor to transfer title to the awarding authority, upon certification by the contractor that he is the lawful owner and that the materials are free from all encumbrances, but less (1) a retention based on its estimate of the fair value of its claims against the contractor and less (2) a retention for direct payments to subcontractors based on demands for same in accordance with the provisions of section thirty-nine F, and less (3) a retention not exceeding five per cent of the approved amount of the periodic payment. After the receipt of a periodic estimate requesting final payment and within sixty-five days after (a) the contractor fully completes the work or substantially completes the work so that the value of the work remaining to be done is, in the estimate of the awarding authority, less than one per cent of the original contract price, or (b) the contractor substantially completes the work and the awarding authority takes possession for occupancy, whichever occurs first, the awarding authority shall pay the contractor the entire balance due on the contract less (1) a retention based on its estimate of the fair value of its claims against the contractor and of the cost of completing the incomplete and unsatisfactory items of work and less (2) a retention for direct payments to subcontractors based on demands for same in accordance with the provisions of section thirty-nine F, or based on the record of payments by the contractor to the subcontractors under this contract if such record of payment indicates that the contractor has not paid subcontractors as provided in section thirty-nine F. If the awarding authority fails to make payment as herein provided, there shall be added to each such payment daily interest at the rate of three percentage points above the rediscount rate than charged by the Federal Reserve Bank of Boston commencing on the first day after said payment is due and continuing until the payment is delivered or mailed to the contractor; provided. that no interest shall be due, in any event, on the amount due on a periodic estimate for final payment until fifteen days (twenty-four days in the case of the commonwealth) after receipt of such a periodic estimate from the contractor, at the place designated by the awarding authority if such a place is so designated. The contractor agrees to pay to each subcontractor a portion of any such interest paid in accordance with the amount due each subcontractor.

The awarding authority may make changes in any periodic estimate submitted by the contractor and the payment due on said periodic estimate shall be computed in accordance with the changes so made, but such changes or any requirement for a corrected periodic estimate shall not affect the due date for the periodic payment or the date for the commencement of interest charges on the amount of the periodic payment computed in accordance with the changes made, as provided herein; provided, that the awarding authority may, within seven days after receipt, return to the contractor for correction, any periodic estimate which is not in the required form or which contains computations not arithmetically correct and, in that event, the date of receipt of such periodic estimate shall be the date of receipt of the corrected periodic estimate in proper form and with arithmetically correct computations. The date of receipt of a periodic estimate received on a Saturday shall be the first working day thereafter. The provisions of section thirty-nine G shall not apply to any contract for the construction, reconstruction, alteration, remodeling, repair or demolition of any public building to which this section applies.

All periodic estimates shall be submitted to the awarding authority, or to its designee as set forth in writing to the contractor, and the date of receipt by the awarding authority or its designee shall be marked on the estimate. All periodic estimates shall contain a separate item for each filed subtrade and each sub-subtrade listed in sub-bid form as required by specifications and a column listing the amount paid to each subcontractor and sub-subcontractor as of the date the periodic estimate is filed. The person making payment for the awarding authority shall add the daily interest provided for herein to each payment for each day beyond the due date based on the date of receipt marked on the estimate.

A certificate of the architect to the effect that the contractor has fully or substantially completed the work shall, subject to the provisions of section thirty-nine J, be conclusive for the purposes of this section.

Article 3. Claims for Unforeseen Conditions (M.G.L. c. 30 §39N)

Every contract subject to section forty-four A of chapter one hundred and forty-nine or subject to section thirtynine M of chapter thirty shall contain the following paragraph in its entirety and an awarding authority may adopt reasonable rules or regulations in conformity with that paragraph concerning the filing, investigation and settlement of such claims:

If, during the progress of the work, the contractor or the awarding authority discovers that the actual subsurface or latent physical conditions encountered at the site differ substantially or materially from those shown on the plans or indicated in the contract documents either the contractor or the contracting authority may request an equitable adjustment in the contract price of the contract applying to work affected by the differing site conditions. A request for such an adjustment shall be in writing and shall be delivered by the party making such claim to the other party as soon as possible after such conditions are discovered. Upon receipt of such a claim from a contractor, or upon its own initiative, the contracting authority shall make an investigation of such physical conditions, and, if they differ substantially or materially from those shown on the plans or indicated in the contract documents or from those ordinarily encountered and generally recognized as inherent in work of the character provided for in the plans and contract documents and are of such a nature as to cause an increase or decrease in the cost of performance of the work or a change in the construction methods required for the performance of the work which results in an increase or decrease in the cost of the work, the contracting authority shall make an equitable adjustment in the contract price and the contract shall be modified in writing accordingly.

Article 4. Claims for Delay (M.G.L. c. 30 §390)

Every contract subject to the provisions of section thirty-nine M of this chapter or subject to section forty-four A of chapter one hundred forty-nine shall contain the following provisions (a) and (b) in their entirety and, in the event a suspension, delay, interruption or failure to act of the awarding authority increases the cost of performance to any subcontractor, that subcontractor shall have the same rights against the general contractor for payment for an increase in the cost of his performance as provisions (a) and (b) give the general contractor against the awarding authority, but nothing in provisions (a) and (b) shall in any way change, modify or alter any other rights which the general contractor or the subcontractor may have against each other.

- (a) The awarding authority may order the general contractor in writing to suspend, delay, or interrupt all or any part of the work for such period of time as it may determine to be appropriate for the convenience of the awarding authority; provided however, that if there is a suspension, delay or interruption for fifteen days or more or due to a failure of the awarding authority to act within the time specified in this contract, the awarding authority shall make an adjustment in the contract price for any increase in the cost of performance of this contract but shall not include any profit to the general contractor on such increase; and provided further, that the awarding authority shall not make any adjustment in the contract price under this provision for any suspension, delay, interruption or failure to act to the extent that such is due to any cause for which this contract provides for an equitable adjustment of the contract price under any other contract provisions.
- (b) The general contractor must submit the amount of a claim under provision (a) to the awarding authority in writing as soon as practicable after the end of the suspension, delay, interruption or failure to act and, in any event, not later than the date of final payment under this contract and, except for costs due to a suspension order, the awarding authority shall not approve any costs in the claim incurred more than twenty days before the general contractor notified the awarding authority in writing of the act or failure to act involved in the claim.

Article 5. Decisions and Approvals by Owner or Designer (M.G.L. c. 30 Section 39P)

Every contract subject to section thirty-nine M of this chapter or section forty-four A of chapter one hundred forty-nine which requires the awarding authority, any official, its architect or engineer to make a decision on interpretation of the specifications, approval of equipment, material or any other approval, or progress of the work, shall require that the decision be made promptly and, in any event, no later than thirty days after the written submission for decision; but if such decision requires extended investigation and study, the awarding authority, the official, architect or engineer shall, within thirty days after the receipt of the submission, give the party making the submission written notice of the reasons why the decision cannot be made within the thirty day period and the date by which the decision will be made.

Article 6. Preference in Employment, Wages (M.G.L. c. 149 §26)

In the employment of mechanics and apprentices, teamsters, chauffeurs and laborers in the construction of public works by the commonwealth, or by a county, town, authority or district, or by persons contracting or subcontracting for such works, preference shall first be given to citizens of the commonwealth who have been residents of the commonwealth for at least six months at the commencement of their employment who are veterans as defined in clause Forty-third of section 7 of chapter 4 and who are qualified to perform the work to which the employment relates and, within such preference, preference shall be given to service-disabled veterans; and secondly, to citizens of the commonwealth generally who have been residents of the commonwealth for at least six months at the commencement of their employment, and if they cannot be obtained in sufficient numbers, then to citizens of the United States, and every contract for such work shall contain a provision to this effect. Each county, town or district in the construction of public works, or persons contracting or sub-contracting for such works, shall give preference to veterans and citizens who are residents of such county, town, authority or district and, within such preference, preference shall be given to servicedisabled veterans. The rate per hour of the wages paid to said mechanics and apprentices, teamsters, chauffeurs and laborers in the construction of public works shall not be less than the rate or rates of wages to be determined by the commissioner as hereinafter provided; provided, that the wages paid to laborers employed on said works shall not be less than those paid to laborers in the municipal service of the town or towns where said works are being constructed; provided, further, that where the same public work is to be constructed in two or more towns, the wages paid to laborers shall not be less than those paid to laborers in the municipal service of the town paying the highest rate; provided, further, that if, in any of the towns where the works are to be constructed, a wage rate or wage rates have been established in certain trades and occupations by collective agreements or understandings in the private construction industry between organized labor and employers, the rate or rates to be paid on said works shall not be less than the rates so established; provided further, that in towns where no such rate or rates have been so established, the wages paid to mechanics, teamsters, chauffeurs and laborers on public works, shall not be less than the wages paid to the employees in the same trades and occupations by private employers engaged in the construction industry. This section shall also apply to regular employees of the commonwealth or of a county, town, authority or district, when such employees are employed in the construction, addition to or alteration of public buildings for which special appropriations of more than one thousand dollars are provided. Payments by employers to health and welfare plans, pension plans and supplementary unemployment benefit plans under collective bargaining agreements or understandings between organized labor and employers shall be included for the purpose of establishing minimum wage rates as herein provided.

Article 7. Hours of Work (M.G.L. c 149 §34)

Section 34. Every contract, except for the purchase of material or supplies, involving the employment of laborers, workmen, mechanics, foremen or inspectors, to which the commonwealth or any county or any town, subject to section thirty, is a party, shall contain a stipulation that no laborer, workman, mechanic, foreman or inspector working within the commonwealth, in the employ of the contractor, sub-contractor or other person doing or contracting to do the whole or a part of the work contemplated by the contract, shall be required or

permitted to work more than eight hours in any one day or more than forty-eight hours in any one week, or more than six days in any one week, except in cases of emergency, or, in case any town subject to section thirty-one is a party to such a contract, more than eight hours in any one day, except as aforesaid; provided, that in contracts entered into by the department of highways for the construction or reconstruction of highways there may be inserted in said stipulation a provision that said department, or any contractor or sub-contractor for said department, may employ laborers, workmen, mechanics, foremen and inspectors for more than eight hours in any one day in such construction or reconstruction when, in the opinion of the commissioner, public necessity so requires. Every such contract not containing the aforesaid stipulation shall be null and void.

Article 8. Work by Foreign Corporations (M.G.L. c 30 §39L)

The commonwealth and every county, city, town, district, board, commission or other public body which, as the awarding authority, requests proposals, bids or sub-bids for any work in the construction, reconstruction, alteration, remodeling, repair or demolition of any public building or other public works (1) shall not enter into a contract for the work with, and shall not approve as a subcontractor furnishing labor and materials for a part of the work, a foreign corporation which has not filed with the awarding authority a certificate of the state secretary stating that the corporation has complied with requirements of section 15.03 of subdivision A of Part 15 of chapter 156D and the date of compliance, and further has filed all annual reports required by section 16.22 of subdivision B of Part 16 of said chapter 156D, and (2) shall report to the state secretary and to the department of corporations and taxation any foreign corporation performing work under such contract or subcontract, and any person, other than a corporation, performing work under such contract or subcontract, and residing or having a principal place of business outside the commonwealth.

Every contractor or subcontractor is required to keep these records and preserve them for a period of three years from the date of completion of the contract.

For CM AT RISK projects (bid pursuant to G.L. c.149A), the earlier of: (a) the execution date of the GMP Amendment, or (b) the bid for the first construction scope of work must be within 90-days of the wage schedule issuance date.
- The wage schedule shall be incorporated in any advertisement or call for bids for the project as required by M.G.L. c. 149, § 27. The wage schedule shall be made a part of the contract awarded for the project. Any apprentice not registered with DAS regardless of whether they are registered with another federal, state, local, or private agency must be paid the journeyworker's rate.
- Every contractor or subcontractor working on the construction project must submit weekly payroll reports and a Statement of Compliance directly to the awarding authority by mail or email and keep them on file for three years. Each weekly payroll report must contain: the employee's name, address, occupational classification, hours worked, and wages paid. Do not submit weekly payroll reports to DLS. - Contractors with questions about the wage rates or classifications included on the wage schedule have an affirmative obligation to inquire with DLS at (617) 626-6953.
- Contractors must obtain the wage schedules from awarding authorities.
