1. OSC Administration

2. Open Space Budget Update

The committee did not see a good opportunity for a booth or handouts at Eco-Fest.

- Discussed plans to launch the OS Plan to each key Town Board/Committee. This
 would include a visit each key department with new OS Plan and a review of that
 department's goals. It's expected there would be discussion of goals and
 timelines.
- Spring Fling This fair will be held in Arlington Heights on June 10, 2-5. It is a
 possible opportunity to share the OS plan as well. More information will be
 available soon.

 - Attendee Beth Melofchik spoke to advocate support for Article 12, a pause in the use of artificial turf for 2 years. Beth noted seminars on April 13 and April 16 regarding PFAS for those interested.
