Minutes

Stone Consultants presentation

Mr. Stone and Mr. Edgars presented the preliminary results of the January 1, 2021, Actuarial Study. Mr. Stone told the Board that due to the return on investments in 2020 the Board is 60.9% funded and the Board would be fully funded in 2034 instead 2035 as projected last year, and this included the agreement with the Town to increase the funding schedule at a rate of 6%. The Board informed Mr. Stone and Mr. Edgars that Board will discuss the funding schedule options and have meeting schedule with Town officials and will inform them which funding schedule they decide to use.
