Addendum No. 1

The attention of Bidders submitting bids for the above-referenced project is called to the following Addendum to the Invitation for Bids. The items set forth herein, whether of omission, addition, substitution, or clarification, shall be included in and form a part of the proposal submitted and shall become part of the Contract.

1. Bidder Question Responses:

- Question: Is this a MassDOT prequalification project? If so, what is the class of work? Please verify the project estimate.
 - Answer: No, this is not a MassDOT prequalification project. The project estimate represents the Town's best approximation of the work to be completed based on currently available information. It is anticipated that the scope of work at some locations will be Test Pits only.
- Question: Can the Town provide a list of the proposed water services they intend to do on the project?
 - Answer: A list of projected locations to be investigated under this project is listed below, as well as what available records indicate the public-side and private-side service materials may currently be. As noted in the technical specifications, Test Pits will be required at each location to confirm the scope of replacement work required, if any. Based on previous lead service replacement efforts in Town, it is anticipated that approximately half of the locations noted below will already have "full" length copper services. Additionally, the Town is actively trying to classify service materials for properties with suspected lead service lines. As such, it is possible that some locations may be removed from this list by the time the contract is executed.
