VISITORS: Dave John

MINUTES of 3/1 approved as amended. Unanimous

ART 51 VACATION ROLLOVER: Tosti has discussed w/ Personnel Director. He has submitted a draft vote to the Town Counsel.

ART UNCLE SAM COMMITTEE: Brief discussion of dissolving this committee in favor of a broader tourism committee being formed by BoS.

ART 37 COMPENSATION OF BoS: Members provided handout w/ info about other towns & opinion from Town Counsel for reference at next meeting.

BUDGETS: In each case the reporting subcommittee commented on activities of the department that provided background for FinCom members.

BUD 3 MANAGER: GenGov SubCom (Howard) recommended the budget as printed. VOTED \$417,916 Unanimous

BUD 11 TOWN CLERK: GenGov SubCom (DuBois) revised the printed budget to agree w/ the Clerk's request. These changes are driven by the increase from 1 to 3 elections. She also discussed breaking out the election and town meeting costs from the other department expenses. VOTED \$234,810 Unanimous

BUD 12 REGISTRARS:: GenGov SubCom (DuBois) also revised this budget for the same reason. VOTED \$59.873 Unanimous

BUD 14 PLANNING GenGov SubCom (Howard) corrected a small longevity error.

VOTED \$231,352 Unanimous

BUD 15 REDEVELOPMENT GenGov SubCom (Howard) made 2 corrections to the Gibbs building budget. He also reviewed the financial plan developed & maintained by the Planning Dept for the buildings. He will provide copies of this plan to members.

VOTED \$270,454 Unanimous.

BUD 17g STREET LIGHTS PubWks SubCom (Deshler) recommended the budget as printed. VOTED \$418,893 Unanimous They will inquire about the Town's electricity contract, future plans for the street lights and the fire alarms.

BUD 19 INSPECTIONS: PubSafe SubCom (Simmons) reported that revenue from inspection fees is running well ahead of last year. He recommended the budget as printed. VOTED \$367,894 Unanimous

BUD 23 PENSIONS: Financial SubCom (Carman) corrected the non-contrib figure. VOTED 7,003,065 Unanimous
