VISITORS: Minuteman Tech Superintendent Ed Bouquillon, Minuteman School Committee Member from Arlington Laura Morrissette

MINUTES of 3/18/09 accepted as corrected. Unanimous

TRANSFER: Voted to transfer \$80,000 from the Reserve Fund to Veterans Services based on material provided by the manager by email. 75% of this is expected to be reimbursed. Unanimous.

ART 40 POSITIONS RECLASSIFICATION: Phelps, using a handout detailing the changes, recommended the proposal from the Director of Personnel. Most of the changes were proposed by managers. The associated costs are in the budget. Two of the eleven proposed by employees were approved by the director. These costs, totaling \$4366, will be in the article. VOTED favorable action. Unanimous. Phelps to email info to Turkall for the report.

ART 44 MINUTEMAN TECH: Bouquillon, using handouts and info previously provided via email by DeCourcey, explained his budget. It has increased by 2.9% but Arlington's assessment has decreased by 1.9%. Our per pupil cost will be \$22,892, a 7% increase. Bouquillon continues to adjust the programs to fit demand & changing industry needs. He described the strengthened outreach program. Still the number of students continues to shrink. He answered many questions. After a lively discussion VOTED \$3,090,368. Unanimous.

ART 45 MINUTEMAN STABILIZATION FUND: Bouquillon stated that the buildings need work. He is starting with an energy plan which should pay for itself over time. Morrissette said the committee backs the plan. The fund would require approval by a majority of the member communities to establish but a 2/3 approval to appropriate money from. It is unclear if appropriations could be restricted to capital use. Members discussed whether this might be a good time to get a charter change since the capital expenditures that the school is expected to need will require unanimous approval from the member towns. Minuteman needs to attract new communities which probably requires a charter change.

SPECIAL TOWN MEETING (STM)

STM ART 3 UNUSED 200th ANNIVERSARY FUNDS: Members were cool to the proposal to spend most of this money on sister cities 25th anniversary celebration. Tabled until discussed w/ Manager.

STM ART 4 "9C" AMMENDMENTS TO FY 09 BUDGET: The Manager provided, by email, a list of cuts. VOTED to recommend the changes as approved. Unanimous.

STM ART 5 REPAIR OF WHITEMORE_ROBBINS HOUSE: Repairs done and general fund should be reimbursed from the building insurance fund. VOTED to transfer \$60,500. Unanimous.

STM ART 6 MODIFY CAPITAL BUDGET FOR FIRE STATIONS: The committee discussed a proposed vote drafted by bond counsel that would authorize borrowing \$12m to rennovate Central and/or Highland stations. VOTED to approve. Bayer to discuss w/ Shea to be sure the wording matches the PTBC needs.

STM ART 7 MODIFY CAPITAL BUDGET: This is intended to provide a means to receive stimulus funds. Tabled pending more info from state.

ART 27 AFTER SCHOOL SCHOLARSHIP FUND: FinCom will not take a position.

ART 28 RAISE MAX AGE FOR POLICE & FIRE CANDIDATES Public Safety SubCom (Bayer) reported that both chiefs support Art 28 that would raise age limits for police & fire candidates but oppose Art 29 that would eliminate age limits. FinCom will not take a position on ART 28.

ART 29 ELIMINATE MAX AGE FOR POLICE & FIRE CANDIDATES Members were concerned with impact on health, insurance & pension costs if the average age of uniformed employees were to increase substantially. VOTED no action 11-3.

ART 32 COMMITTEE ON REORGANIZATION: Tabled

ART 33 PAYT Ad hoc subcom (Howard & Ferrara) presented a proposed vote & a sample budget impact table. Discussion cut off by the clock.

COMMITTEE: Next mtg 4/13 There will be a Bud & Rev Task Force mtg at 6:00. FinCom will meet 9:00 AM Saturday 5/9 to vote on the budget. The House may have voted local aid by then. The Schools will hold a public budget hearing on 4/28.

RESERVE FUND BALANCE: \$287,000-\$80,000=\$207,000.
