VISITORS: Members of the Capital Planning Committee: Charlie Foskett (Chair), Steve Gilligan (TownTreasurer), Susan Mazzarella (School Dept), John FitzMaurice, Barbara Thornton

MINUTES of 2/27 approved as corrected. Unanimous.

BUD 3 TOWN MANAGER: GenGov SubCom (Howard) recommended the budget as printed. He reviewed the use being made of the funds for the vacant position and the increase in web site expense.

VOTED \$460,104 Unanimous

BUD 4 PERSONNEL: Personnel SubCom (Phelps) recommended the budget as printed.

VOTED \$190,113 Unanimous

BUD 9 ASSESSORS: Finances SubCom (McGaffigan) recommended the budget as printed but made some shifts in the expense line items. The reval was not done this year because assessors could not find a firm to do it. Will be done next year.

VOTED \$301,270 Unanimous

LIBRARY: Franclemont reported that the new circulation desk will not require appropriation. The library still has no Thursday morning or Sunday hours.

ART 53 CAPITAL BUDGET: Foskett, using a 37 page handout, introduced the committee & reviewed the capital planning process and recent achievements. He showed how the capital plan is based on 5% of the predicted future revenues including after 2010 when there is a predicted deficit. Each of the committee members reviewed significant details of the parts of the budget they had worked on. Thornton & Mazzarella discussed the Thompson & Stratton investments and the steps being taken to make sure that the MSBA approves investments so that they would eventually qualify for reimbursement. Foskett tallied funds that might be made available for this use at \$14.2m. He said the initial step would be to carry out a \$200k professional plan of what to do and when w/ the resources available. Thornton discussed a new effort to coordinate facility security. Gilligan reviewed the parks & fields renovations & the public works projects. FitzMaurice reviewed the police & fire requests. The community safety building renovation will start with the garage roof for now. A quint fire truck is planned since it can do the job of a ladder & pumper but proper staffing is not settled. Gilligan said that recent replacement of the chiller at the rink took care of the most urgent need. The Town can not charge user fees sufficient to pay for the \$1.8m improvements required. FinCom members asked numerous questions, many to Gilligan concerned w/ borrowing policy.

ART 58 RESCIND AUTHORITY TO BORROW: Gilligan, in a memo to the CPC, 9 items for which funds were no longer needed. VOTED to rescind authority to borrow totaling \$2,724,175 as recommended by the Treasurer. Unanimous

BUD 11 TOWN CLERK: GenGov SubCom (DuBois) made several reductions and summarized these and the Registrar budget changes on a handout.

VOTED \$234,177 Unanimous.

BUD 12 REGISTRAR OF VOTERS: GenGov SubCom (DuBois) discussed the new position which is really a budget for part time help. The handout shows this appointing authority has a 6% increase, well over the 2.7% (due to health insurance) limit. Members

requested justification for the new position or perhaps treating it as a special presidential election year expense.

VOTED to table pending more info. Unanimous.
