VISITORS: None

MINUTES of 3/10 approved as corrected. Unanimous.

BUD 14 PLANNING: GenGov SubCom(Howard) asked for reconsideration of vote on 3/10 to correct an error. VOTED \$228,266. Unanimous.

BUD 7 TREASURER: Finance SubCom(Carman) recommended the budget as printed. He also explained the Treasurer's intent to consolidate 2 part time positions in order to fund a financial analyst at no net cost. VOTED \$577,693. 15-0-1.

BUD 8 POSTAGE: Finance SubCom(Carman) recommended several changes to the expenses as printed.

VOTED: \$99,243. 15-0-1.

TREASURER'S TRUST FUNDS: Carman reported that these funds, totaling \$20m to \$25m, have lost about \$1m due to the mortgage crisis. This is less than the market as a whole. The Treasurer is considering whether the advice to buy the mortgage funds was legal. If not, he will attempt to recover some of the losses. A more immediate concern is a possible loss of interest income in FY 09 of \$600k, a change not reflected in the current 5 yr plan.

BUD 18a COMMUNITY SAFETY ADMIN: PubSafe SubCom(Simmons) recommended the budget as printed. The Manager will attempt to fund the Fire Chief's buyout from elsewhere in budget.

VOTED \$373,299. Unanimous.

BUD 18b POLICE: PubSafe SubCom(Simmons) recommended the budget as printed. The new staffing will be 2 Capt, 8 LT, 9 Sgt, 46 Officers. Eight new hires are planned to replace 3 retirees. Lateral transfers are unlikely. Arlington will then have a police/resident ratio of 1.5 compared to 2.2 state wide.

VOTED \$5,487,813. Unanimous.

BUD 18d SUPPORT: PubSafe SubCom(Simmons) recommended the budget as printed. The enhanced 911 system was used to justify the reclassification of dispatchers.

VOTED \$684,043. Unanimous.

BUD 19 INSPECTIONS: PubSafe SubCom(Bayer) discussed the inspection work at Symmes. In the interest of transparency, the FinCom report will include the overtime & outsourced work at Symmes in the budget & show a \$35,000 offset from the Symmes urban renewal project.

VOTED \$351,192. Unanimous.

BUD 20 EDUCATION: Ed SubCom(Ronan) recommended the budget as printed in the 5 yr plan. She reported that the School Committee quickly agreed on a fee increase to avoid teacher reduction & provided a copy of the motion that was voted. Fanning noted that the Superintendent is doing a good job. He has not yet responded to the FinCom's request for METCO financial info.

VOTED: \$37,878,871. Unanimous.

Tosti yielded the chair to Foskett for the duration of the meeting.

YOUTH SERVICES EF: HumSer SubCon(Franclemont) recommended the budget as revised in February. She noted that the grant reduction reflects this year's experience. The director is working to fund some of the social workers dropped by the schools w/ grants.

VOTED Expenses \$479,447, revenue \$192,832, from General Fund \$286,645. Unanimous.

ART 47 POBs: During an extended discussion, members expressed concern w/ the Town proposing to invest borrowed funds, especially considering lack of success stories elsewhere in MA. At the same time, members thought that enabling the Town to do this should conditions warrant, was a good idea if there were enough safety steps.

VOTED to request special legislation to allow Arlington to sell POBs 15-1 with constraints voted individually as follows. The amount borrowed not to exceed 20% of the value of the Pension Trust Funds, 9-7; approval required by a 2/3 vote of Town Meeting ,15-1; by the FinCom, 14-2; by the BoS, unanimous; by the Treasurer, unanimous. And further that the Town Counsel be asked to draft a recommended vote for Town Meeting.

BUD 23 RETIREMENT: Finance SubCom(Dunn), using a handout, recommended a 4% budget increase which is net of CRB expenses. He noted that the insurance budget should show an offset of \$15,000 for health insurance reimbursement from the CRB.

VOTED \$6,951,511. Unanimous.

BUD 17 PUBLIC WORKS: PubWks SubCom(Olsen) requested reconsideration of the 2/11 vote to reflect the recent contract to outsource most of the cemetery maintenance. He furnished a handout.

VOTED: \$6,775,374. Unanimous.
