  - b. Crosswalk across Dickson at Christine, move to Phase 2, after sidewalk installed on Dickson.
4. Peirce Phase 1A Recommendations to Selectmen. Voted unanimously.
  - a. Extend School Zone
  - b. Install school drop-off and parking restriction signs at both drop-off areas.
5. Demand Management Update. Memo summarizing activities is going to Selectmen. Laura reported on recent meetings with ACC and ISB (tenants at Parmenter School). Meetings with staff to promote commuting alternatives to driving alone planned for last week of August.
6. Thermoplastic Crosswalk Planning. Mike will develop prioritized list and email to TAC members for feedback.
7. Mass. Ave. Corridor Update. Construction money was placed on TIP for FY 2010. Design money still has not been released, but looks promising now that construction money is also on the TIP.
