Mrs. Mahon made a motion to re-open the decision of the Board at their meeting of July 22nd regarding the suspension of the Shanghai Village Restaurant, Szechuan's Dumpling and Not Your Average Joe's. Mr. Curro seconded said motion for discussion only.

Selectmen Mahon and Greeley expressed concern that Not Your Average Joe's representatives were given a lighter punishment because they could express themselves better than the other restaurant owners who struggled communicating in English when the other Board members pressed them for plans to prevent future violations. Mr. Greeley stated that he felt that we should give Shanghai and Szechuan's Dumpling a little break when we add language as an issue. He also stated that this was Shanghai Village's first violation in 30 years of business in Arlington.

Mrs. Mahon stated she disagreed with the Board's decision to allow NYAJ to select the three days of its suspension. Mrs. Mahon stated in the past the suspension begins on the same weekday as the violation occurred. Mrs. Mahon stated she feels the Board gave Not Your Average Joe's more leeway after being impressed by what they saw as proactive preventative alcohol measures.

Mr. Byrne and Mr. Curro defended the board's ability to use its discretion and said their initial decision was based on commitment to change and not communication skills.

Mr. Dunn apologized to Ms. Lo for a misunderstanding at the hearing on July 22nd starting that when he asked he if she was willing to do any concrete steps to change things, Ms. Low responded "no" which answer left him flabbergasted. He later realized that he hadn't understood the question. Mr. Dunn stated he regretted that miscommunication happened.
